School Description and Mission Statement (School Year 2010-11)

Phoenix Academy's goal is to provide those adolescents who have abused alcohol and/or other drugs with an innovative academic and treatment program. In partnership with their families and the community, this program supports their ability to make a long-term commitment to sobriety and to become a contributing member of society. Phoenix Academy, Marin County's first Charter School, is operated by the Marin County Office of Education in partnership with Bay Area Community Resources. Phoenix Academy is designed to offer alternative educational services to students with, or at high risk for, chemical dependency problems.

Opportunities for Parental Involvement (School Year 2009-10)

This section provides information about opportunities for parents to become involved with school activities.

Parent involvement is a critical aspect of student success in Phoenix Academy. Families commit to attending participating in the therapeutic program. Quarterly Review meetings that include academic and treatment staff, the student, the parent and the probation officer provide another opportunity for parent involvement. Parent education is also available through Bay Area Community Resources. Parents are encouraged to be a part of the team effort for their students. Back to School Night, Open House and Graduation are more formal ways for parents to demonstrate support for their students. Graduation occurs three times per year (October, February and June), Back to School Night is in September and Open House is held in April. Parents are also encouraged to participate in the Phoenix Academy Advisory Council which meets quarterly.

School Facility Conditions and Planned Improvements (School Year 2010-11)

<p>Marin County Office of Education takes great effort to ensure that all program sites are clean, safe and functional. Phoenix Academy is a closed campus. To ensure school safety, campus supervision staff patrol the campus and vicinity 30 minutes before school to ensure that students arrive safely. Staff patrol the area around the school and up to the local bus stop at least 15 minutes after school until students board buses to leave the area. Campus supervision staff are equipped with two-way communication devices. Staff members share responsibility for patrolling the campus throughout the day to supervise the grounds and buildings. All staff are trained to intercede with unfamiliar persons on the campus and direct them to the school office. Signs are posted directing visitors on campus to check-in at the school office. There is a visitor sign-in book with identification badges that are affixed to visitor's clothing in a visible manner. Phoenix Academy is in a leased property that was built in the 1950's. It has two classrooms, a computer lab, a counseling office and a school office, separate boys' and girls' bathrooms, a staff room and staff bathrooms. A portable building constructed in 2001 is used for counseling and an alternative to suspension program. Students participate in physical education activities on an asphalt play area. Marin County Office of Education maintenance staff ensure that repairs necessary to keep the school in good working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given highest priority. Classrooms and restrooms are cleaned each evening. All classrooms are inspected regularly to ensure safety and the proper use of equipment.</p> <p>For the 2010-2011 school year, Marin County Office of Education budgeted \$2,006,853 for the deferred maintenance program. This represents .0357% of the district's general fund budget.</p>

Textbooks and instructional materials are selected by teachers based on a review of state-adopted textbooks and students' needs. 9-12 locally adopted textbooks and other instructional materials allow students to access the core curriculum and are consistent with the content standards and cycles of the California curriculum frameworks. California State Instructional Materials funds are used to purchase instructional materials and textbooks for Marin County Office of Education Phoenix Academy. Program budgets, categorical funding and state textbook allocations provide funding to ensure all students have access to the core curriculum through state and board adopted texts. Each year staff evaluates the quality, availability and sufficiency of instructional materials. Students have access to sufficient textbooks and materials at the appropriate grade level to meet their in-class and home needs.

VIII. School Finances

Expenditures Per Pupil and School Site Teacher Salaries (Fiscal Year 2009-10)

Types of Services Funded (Fiscal Year 2009-10)

This section provides information about the programs and supplemental services that are provided at the school through either categorical funds or other sources.

The funding for Phoenix Academy comes from state apportionment through the California Department of Education. The 2009-2010 state apportionment is calculated using the 2009-2010 base revenue limit per average daily attendance (ADA). The state revenue received for Phoenix Academy in fiscal year 2009-2010 was \$108,939 while the expenditures totaled \$241,139. Funds were used to provide staff salaries and benefits, textbooks and instructional materials, professional development and other expenditures for the implementation of charter school goals.

Phoenix Academy is designed to offer alternative educational services to students with, or at high risk for, chemical dependency problems. The program addresses academic achievement, appropriate behavior in the academic setting, commitment to recovery, continued sobriety, relapse intervention, family intervention and vocational education. Students are referred by school districts, parents, probation officers and by the students themselves.

The primary goal of Phoenix Academy is to provide a safe and sober atmosphere for students who have experienced problems with drugs and alcohol. The program provides intensive therapeutic services to help youngsters in recovery from chemical dependency. In addition, Phoenix Academy provides a challenging, comprehensive curriculum taught by qualified and experienced teachers.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA for grades three through eight and science in grades five and eight and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. Academic Performance Index
